I. Call to Order & Roll Call

- Chair Kinney called the meeting to order, with roll call conducted by Secretary House.
- A quorum was confirmed with all members present.

II. Public Comment

III. Old Business

• October 2024 Meeting Summary: Reviewed and approved unanimously.

IV. Reports

- 1. Treasurer's Report:
 - Presented by Executive Director Woodyard on behalf of Commissioner Vande Lune.
 - The report was accepted as presented.
- 2. Chair's Report:
 - Chair Kinney highlighted significant stakeholder outreach and meetings.
 - Updates covered were addressed in detail in the Executive Director's Report.

3. Bylaws & Rules Committee:

- Commissioner Schmider reported that the bylaws are in final draft status.
- The Ballot Committee is scheduled to meet on December 13 to finalize the draft for a vote.

- The draft bylaws will be posted for public comment in preparation for a February 2025 Full Commission hearing and vote.
- Executive Director Woodyard will schedule overview sessions on the draft administrative rules in January.

4. Data Protection Workgroup:

- Commissioner Bateman presented a summary of the recommendations from the Data Data Protection workgroup. A motion to accept the recommendations from the workgroup, with an amendment to remove "Point #3" and to include National Association of EMS Physicians (NAEMSP) as a collaboration partner in data protection.
 - Motion was made by Commissioner House, seconded by Commissioner Koehler, and approved unanimously.
- The final draft of the Data Protection Position Paper was reviewed by the Executive Committee. Update Position Paper's title to 'Data Protection Position Paper 2025-01', and update the terminology to be consistent with EMS Clinician, as applicable.
 - Motion was made to add this position paper, as adopted for terminology consistency, for consideration by the full commission in February 2025. Motion by Commissioner House, seconded by Commissioner Koehler, and approved unanimously.

5. Executive Director's Report:

- Updates included:
 - Technical assistance provided to Louisiana and Tennessee to ensure consistent application of Compact legislative requirements.
 - Completion of a new five-year agreement with the National Registry of EMTs for continued partnership and technical services.
 - Participation in the U.S. Fire Administration's National Fire Summit and a Wildland Agency meeting.
 - Updates to the EMS Compact website for improved user experience and fresh content.
 - Presentation on the Compact at the Texas EMS Conference.
 - Proposals submitted to EMS World Expo, the Journal of EMS Conference, and the American Ambulance Association Conference.
- $\circ~$ Highlighted the widespread distribution of a video podcast recorded with Prodigy EMS about the EMS Compact.

 - Updates were provided on preparations for the upcoming meeting, including hearings on the draft bylaws and administrative rules.
- 2. Data Protection Workgroup Recommendations:
