I. Call to Order & Welcome

II. Public Comment

III. Old Business

- EMS Workforce Privacy Protection
 - Commissioner Mike Bateman (CO) provided an update. The workgroup did not meet in July, and the next meeting is scheduled for August.
- JEMS Collaboration Update
 - Executive Director Woodyard is continuing work on an agreement with JEMS, which will be presented at a future meeting.

- Treasurer's Report
 - Commissioner Kinney presented the Treasurer's Report in the absence of Commissioner Vande Lune. The report was accepted as presented.
- Review of July 2024 Executive Committee Meeting Summary
 - Motion to approve by Commissioner Koehler (WY), seconded by Commissioner Denny (ID). The motion passed, and the summary was accepted as presented.
- Chair's Report Kinney
 - Commissioner Kinney welcomed new Commissioners from South Dakota and Oklahoma. He also recognized the promotion of Commissioner Mike Bateman to Chief of the Emergency Medical & Trauma Services Branch in Colorado.
 - The Compact website has been updated to include a new section on the National Practitioner Data Bank (NPDB).
 - Commissioner Kinney reviewed the Executive Director's written report and entered it into the meeting record.
- National EMS Coordinated Database Report
 - Ray Mollers from the National Registry of EMTs provided an update on the status of the National EMS Coordinated Database.

V. New Business

- Code of Conduct Update
 - Commissioner Michael Johnson (GA) provided an update on the Privilege to Practice Code of Conduct, which has been revised based on public feedback. The finalized version will be presented to the full Commission in October. The committee discussed next steps, including potential incorporation of the Code of Conduct by reference into a rule, with further consideration by the Rules and Bylaws Committee.
- Amicus Brief Discussion Colorado Paramedic Case
 - Commissioner Bateman (CO) recused himself from the discussion. The Executive Committee and Counsel discussed the appropriateness of filing an amicus brief related to the Colorado Paramedic criminal case. Commissioner Denny made a motion <u>not</u> to proceed with an amicus brief, seconded by Commissioner Koehler (WY). The motion passed. Commissioner Denny clarified that the Commission's decision does not reflect disagreement with other organizations, such as the IAFF, filing amicus briefs, but rather the Commission's position as a governmental body representing multiple states.
- U.S. Department of Education Title IV Funding Public Comment
 - The committee reviewed a proposed public comment letter drafted by the Executive Director regarding Title IV funding. Commissioner Denny motioned to accept the letter and authorize its submission, seconded by Commissioner Koehler (WY). The motion passed.

Public Comment on Proposed Regulation by the U.S. Department of Education

RE: Docket ED-2024-OPE-0050

To Whom It May Concern,

On behalf of the Interstate Commission for EMS Personnel Licensure, the governmental body responsible for the interstate practice of emergency medical services in the United States, we are writing to express our concerns regarding the proposed regulation changes to distance education and the definition of clock hours, as outlined in Docket ED-2024-OPE-0050.

Nationally, EMS is currently grappling with significant recruitment and retention challenges, and these challenges have been amplified in the post-COVID era. EMS agencies nationwide are struggling to maintain adequate staffing levels, and now is not the time to impose regulations that could negatively impact access to EMS education.

As an industry, we have collaborated extensively with our educational partners to expand access to EMS education, particularly in rural, frontier, and underserved areas. One of the critical strategies we have successfully implemented is the judicious and careful use of asynchronous and hybrid courses for portions of EMS education, including paramedic education. This approach allows us to maximize in-person time for essential clinical elements while providing flexibility for theoretical components.

The proposed changes to eliminate asynchronous instruction for clock-hour programs could severely hinder our ability to deliver effective and accessible EMS education. This is especially true in regions where in-person attendance poses significant logistical challenges for students.

Therefore, we respectfully request a "public safety exemption" to the proposed clock-hour rule changes. Specifically, we urge the Department of Education to grant an exemption for EMS programs, as well as fire and law enforcement programs. This exemption would allow these critical public safety education programs to continue using asynchronous and hybrid instructional methods to ensure comprehensive and accessible training for future EMS personnel.

In summary, it is crucial to consider the unique needs and challenges of public safety and EMS education in the context of these regulatory changes. We believe that a public safety exemption will support the continued delivery of high-quality EMS education, ultimately benefiting the health and safety of communities nationwide.
